

- B. At this point the assembly is secured by its own weight; bolts are unnecessary.
- C. Heavy galvanized steel bracket for rigidity.



- Both ends of the strap are bent over 1. 3" to 5" (8 cm - 12 cm)
- 2. Hook the ends through the slots in the bracket.
- 3. Suspend the assembly from a droprod or attach directly to the ceiling.
